## **FSS Program Update**

The Public Housing Family Self-Sufficiency Program began in the summer of 2005 and can serve up to 50 individuals.

The objective of the FSS Program is to help motivated families move toward selfsufficiency. The process involves a five year contract between the head-of-household and Charleston-Kanawha Housing in which the individual states their goals and activities for achieving self-sufficiency. Once the contract is signed, the FSS Coordinator can work with any member of the household toward self-sufficiency goals such as:

- Free Counseling Services
- Free GED Classes
- Improve Credit
- Obtain Job Training
- Assist with College Enrollment
- Improve Employment Status
- Obtain Child Care, etc.
- Homeownership Counseling
- Provide Links to Various Social Services

FSS participants will establish an escrow account once their income increases. The difference in their rent increase is placed into an account that is available to the participant upon successful completion of the program.

FSS participants may also choose to establish an Individual Development Account, IDA, which receives a dollar for dollar match from Charleston-Kanawha Housing up to \$1,500. The IDA can only be used for homeownership, education/training or starting a business.

Charleston-Kanawha Housing has partnered with Family Service and the Religious Coalition for Community Renewal to provide counseling services for participants.
